SUMMARY OF UAS BUSINESS FOR APRIL 03, 2020 MEETING

The Executive Committee of the Senate (ECS) met three times in March to discuss business of the University Academic Senate (UAS). These meetings were held on the following dates: March 13, March 20 and March 27. At these meetings, ECS either acted on behalf of UAS or supported motions with recommendation to UAS.

A. ACTING ON BEHALF OF UAS:

ECS reviewed the following and acted on behalf of UAS (per SG 1.01 Section 3.1):

- Given the unprecedented circumstances of the COVID-19 pandemic, Senate Leadership working in collaboration with the Office of the Provost, thought a temporary academic policy for the administration of courses and evaluation of students would be in order at this time. Subsequently, ECS charged the Academic Policies and Standards Committee (APSC), to draft temporary academic policies to address the effective administration of courses and equitable evaluation of students until we return to normal operation. At our regular ECS meeting of March 13, 2020, APSC proposed Temporary Academic Policy for COVID-19 Emergency. ECS, acting on behalf of UAS, pursuant to our Shared Governance Policies, SG 1.01.3.3.1, unanimously voted to accept APSC's recommendation and forwarded to the Provost for immediate implementation.
- At our special ECS meeting of March 27, 2020, the Faculty Personnel Policy Committee (FPPC) proposed Emergency Recommendations for Teaching Evaluations, Faculty Service, Faculty Scholarly/Creative Work, and Tenure Clock. ECS, acting on behalf of UAS, pursuant to our Shared Governance Policies, SG 1.01.3.3.1, unanimously voted to accept FPPC's recommendation and forwarded to the Provost for immediate implementation.
